## I received a yellow post card and/or e-mail about an AAUW Data Verification / Oral History Project - Is this a scam?

No, it is not a scam – AAUW is working with PCI to update member data and ask members to participate in an Oral History Project. Post cards were received earlier than anticipated – and an email communication was sent to all members from AAUW on April 25<sup>th</sup>. It is important to note that if you do not receive our emails – you may be unsubscribed or in need of updating your email address with us.

#### What is the Oral History Project?

- The Oral History Project is an effort to collect and memorialize the memories, experiences and impact that AAUW membership has had on the lives of our individual members across the country. These stories will be compiled into both a digital and hardcopy bound book. There is also an opportunity for members to purchase their own copy of the book, as well as other AAUW branded items, if they so choose.

#### How will PCI be contacting me?

 PCI will contact AAUW members directly through postcards and emails, addressed to you from Katrina Sun Breese (Senior Director of Institutional Advancement), to encourage participation.
 PCI will not conduct outbound calls to members, except to return your calls.

#### Why are we doing this project?

- Data Verification While you may have received our post card and recently renewed your
  membership, we often find that emails and phone numbers are out of date. Updating your data
  ensure we can stay in touch with what is happening at AAUW and important information about
  your membership. It is also an added value that PCI is conducting this project, at no cost to
  AAUW National.
  - Thus far over 1/3 of respondents have updated their contact information.
- Oral History AAUW has a long and rich history, well-documented throughout the years in our Archives. We also employ a part-time Archivist and engage the volunteer Archive Corps to organize and maintain this history. That being said the lived experiences of every day members are not well-documented, nor shared broadly. This project will give us access to audio recordings, transcriptions of stories, and photos submitted from members who choose to participate. While conducting a project of this kind would typically be a significant investment, PCI is doing this work at no cost to AAUW.
  - Thus far over 2,000 stories have been shared

#### Why did AAUW choose to work with PCI?

- PCI has a long history working with hundreds of membership associations (such as Shriners International and the National Bar Association) as well as College and University Alumni Associations (such as the University of Chicago Booth School of Business, Texas Women's

University, University of Michigan and more) and there is incredible value in embarking on a project of this kind at no cost to AAUW National.

#### I received a post card, so why do you need to verify my member data?

- If you received a post card, we have your up to date mailing address however, AAUW's primary and most frequent method of communication is email and at times, we may need to reach you by phone. While you may have successfully renewed your membership, we find some details do get missed.
- As of **Friday, April 28**<sup>th</sup> PCI has received nearly 2,900 responses:
  - Over 2,100 stories have been collected
  - Over 300 updated their email addresses
  - Over 1,200 updated their phone numbers
  - Over 1,100 updated cell phone numbers
  - o 86 updated mailing addresses

#### The post card asked me to respond within 5 days, why the short time frame?

PCI adjusts staffing based on the anticipated volume of calls. While the Oral History project information gathering phase will last over the next 6 months, the peak of anticipated call volume will be at the beginning of this time frame. Updating your contact information in a timely manner means our records are as accurate and up to date as possible, and in time for important communications.

#### What happens if I don't respond?

- If you choose not to respond, there is no impact to your membership.

#### Is this a fundraiser for AAUW?

AAUW receives a small royalty of \$10 per package purchased. While a royalty is received this
does not represent a significant fundraiser for AAUW – the greater value is in the updating of
our member data and collection of stories and memories from our members, at no cost to
AAUW.

#### The products are expensive - do I need to purchase to participate?

- No purchase is necessary to participate. While members who purchase a package are guaranteed inclusion of their story in the print edition, there is absolutely no obligation to purchase in order to share your story or update your information.

#### Spring is a busy season for AAUW – why is this project starting now?

Spring is definitely a busy time for AAUW members. Whether it is renewals, fundraisers, state conventions or conferences – AAUW is top of mind for many. Additionally – many are now safely gathering in person and reconnecting with old friends and fellow members. While busy – we know that it is during this time that you are reminiscing with friends about conventions of the past, recalling the time you first joined, celebrating important anniversaries and milestones, and learning so much from one another. As the project takes 1 year to complete, it will also be during this time next year that the finished product will be shared for our members to enjoy.

#### I was unhappy with my customer service experience - how can I share this information?

- While the National office has received inquiries about the project and shared feedback we highly encourage you to share your feedback directly with PCI. Following your call they will ask you to submit feedback through a star rating.
- PCI thus far has received limited ratings feedback directly only 19 responses as of April 28<sup>th</sup> 2023. Of those 19 responses 12 provided a 5 star rating and 7 provided a 4 star rating.
- If for any reason you wish to cancel an order you are able to do so directly through PCI's customer service.
- To Contact PCI:
  - 1-855-454-0718 is a dedicated AAUW update line that members who did not receive a postcard or email can call to update their information / share a story / etc
  - 1-800-982-1590 is PCI's Client Services phone number that members can call for anything after their initial call (questions on the project, cancelling orders, etc)

## I've been getting negative feedback from members about this project – how do we share this feedback?

- AAUW is committed to ensuring we are addressing any concerns about specific member experiences with PCI. We have the ability to flag specific customer experiences and review the audio recordings upon request.
- We also want to encourage you to complete your post-call survey from PCI, so that your experience is shared directly with them.

#### Is my data safe?

- Yes all data shared with PCI is saved on a secure site, which AAUW is able to access and utilize to update our records. They will only utilize the information shared for the purposes of AAUW's Oral History Project.
- Additionally AAUW did not sell member information to PCI. AAUW also did not pay PCI to conduct this project.

#### Adelaide Digiorgi


