DO YOU HAVE THIS CUTE BLUE LOGO ON YOUR BRANCH COMMUNICATIONS? If you do, it is most likely an icon on your website, newsletter, letterhead, email template, etc. It is an embedded link to a LinkedIn page. Clicking the icon will take your members to the state page with all the latest social media posts.

The old page will be deleted sometime later this year, so don't hesitate too long to update your communications.

BRANCH BYLAWS UPDATE

In spring 2023, AAUW members voted overwhelmingly in favor of changes to the national bylaws. Given the nature of changes to the bylaws, all AAUW branches are required to update their bylaws with these mandated changes. **All branches in California will update their bylaws by June 30, 2024.** Click <u>HERE</u> to see the bylaws template that we will discuss at the peer group meeting on October 10th.

AAUW's branch boards can approve the required changes with a vote of the board – a full vote of the branch membership is not required to implement national-mandated changes to branch bylaws. Once you have updated the first seven articles as required, and your branch board has approved the new version, please send your bylaws to governance@aauw-ca.org. AAUW California will save a copy of all branch bylaws and will submit them to AAUW National by their deadline.

If your other articles (beyond the first seven mandated articles) are changed, your branch membership must approve them by vote at your Annual Meeting held in the spring. After approval by your membership, please send them to governance@aauw-ca.org as stated above.

A Governance Peer Group session will be held on Tuesday, October 10th, 7-8 pm to give you more information and answer questions. GET INVOLVED AND BE AN ADVOCATE!

The Public Policy Committee held our first bi-monthly virtual peer group meeting for Branch Public Policy Chairs on October 4th. Click <u>HERE</u> for a video of the meeting.

We introduced the Public Policy Committee, shared legislative updates from AAUW National,

and informed the branch chairs about the various resources that are now available to assist them in their public policy work. We discussed the exciting projects we have planned for the year ahead: developing our Legislative Agenda, engaging in Lobby Days 2024, improving the website, creating a new Social Media Public Education and Action campaign, and of course continuing with the School Board Project, which is already creating quite a buzz. Last but not least, we shared the outcome of AAUW California's legislative agenda for the 2022-23 session.

We hope you were able to join the webinar on September 21st, *Book Banning and Curricula Censorship in California? AAUW California to the Rescue*, presented by Kathi Harper, chair of the School Board Project subcommittee, and panelists Seena Trigas and Jean Slater. Approximately 250 participants representing 79 branches tuned in to hear about how we can take action to combat the movement in California that seeks to install school board members who want to ban books, censor curricula, and establish policies that are harmful to LGBTQ+ students. We learned about the steps AAUW California is taking to identify and promote school board candidates who share AAUW's values and who will respect the laws that require adherence to the State Board of Education's academic standards, including keeping historically accurate and inclusive books and lessons in the curricula.

Finally, we have some great news on the legislative front. AB 1078, an important bill supported by AAUW California and closely aligned with our School Board Project, was signed by Governor Gavin Newsom on September 25, 2023. AB 1078 "Instructional materials and curriculum: diversity," authored by Assemblymember Dr. Corey Jackson, bans "book bans" in schools, prohibits censorship of instructional materials, and strengthens California law requiring schools to provide all students access to textbooks that teach about California's diverse communities.
